As we now enter the month of June, it is hard to believe that we are halfway through 2019. The beginning of summertime is here, then rapidly into the holiday season once again. Construction remains vibrant in our area and our signatory contractors continue to be busy. Work hours are beginning to increase now that the short rainy season has ended. Local 600 continues to be financially sound, we are spending wisely and we've had positive net income for 17 continuous months.

The Business Representatives remain vigilant in their duties and are working hard daily to maintain and create work opportunities for our membership. Unfortunately, the constant weekly battles at prejob meetings and on the job sites to protect our work from raiding by certain unions persist. You, the member are our eyes and ears on the job sites. Your assistance in protecting our work is extremely important, because as you know, the agents cannot be on every job site at all time. Should you notice work being performed by someone other than a Cement Mason, do not attempt to stop or interfere in any way, notify your agent when you are able to do so.

The Funds are doing well, they have rebound and gained back the losses that affected the stock market in the fourth quarter of 2018. The Negotiating Committee takes this and overall reports supplied by our Trust Fund professionals into consideration when deciding on the allocation. The upcoming July 1, 2019 allocation, as in years past, represents a balanced approach based on all this information to ensure each Fund is properly maintained while placing money on wage and vacation. You can see the allocation breakdown on the following pages and you should have received a letter with the new wage/fringes as well.

Enclosed you will find the breakdown for the July 01, 2019 increase of two dollars and five cents (\$2.05). One dollar and twenty-five cents (\$1.25) to wage, twenty cents (\$0.20) to Vacation, four cents (\$0.04) to Supplemental Dues, nineteen cents (\$0.19) to Defined Benefit Pension, twenty-two cents (\$0.22) to Defined Contribution (IRA) and fifteen cents (\$0.15) to Health & Welfare.

### Ingredients

- 2 pounds Cod fillets, cut to approx 3 oz portions and patted dry.
- 2 ¼ Cup all-purpose flour
- Set aside ¼ cup to dust fillets
- Salt-to-taste
- Pepper-to-taste
- Garlic powder-to-taste
- 1 egg
- One 12-oz bottle of any light colored beer
- Corn tortillas
- 1 quart oil for frying

### Cilantro Cream Sauce

- 1 cup sour cream
- ¼ cup green salsa
- ¼ cup or to taste chopped cilantro
- Salt-to-taste
- Garlic powder-to-taste
- ¼ cup lime juice or to taste

### Toppings Optional

- Shredded cabbage
- Avocado slices
- Grilled Jalapeño and/or banana chili

### Instructions

Heat oil in large frying pan to approximately 375 degrees. Mix ½ bottle of beer with the egg then add flour and seasonings and stir until well mixed (you can add more beer if too thick). Lightly dust Codfish fillets with remaining flour then dip in batter and fry until golden (about 3 minutes on each side). Remove and place on a sheet lined with paper towels. Warm up tortillas, add fish, cilantro, cream and desired toppings.

*Note, This batter could be used on shrimp, calamari or onion rings.*

The 2017-2021 Cement Masons Master Labor Agreement provides for a \$2.05 per hour increase effective July 1, 2019. The Union has determined to allocate the increase as follows: **Vacation: \$0.20 increase, Administration Dues: \$0.04 increase, Defined Contribution Plan (IRA): \$0.22 increase, Defined Benefit Plan (Pension): \$0.19 increase, Health & Welfare: \$0.15 increase and to Wages: \$1.25 increase.**

Effective July 1, 2019, the following wage rates are payable to Commercial Apprentice Cement Masons:
